

## **Financial Assistance Scheme**

### **Terms & Conditions**

1. The Financial Assistance for DIMENSIONS' Cambridge Primary Programme(s) / High School Programme(s) covers flexible instalment plans and the reduction of course fees which is subject to the Management's approval.
2. This Financial Assistance Scheme is open only for May 2018 intake.
3. Applicants must meet the admission requirements of DIMENSIONS' Cambridge Primary Programme(s) / High School Programme(s) to be eligible for the Financial Assistance application.
4. The Financial Assistance Scheme is applicable only to Singaporeans, Permanent Residents and International Students.
5. Applicants aged 7-16 years old are eligible to apply.
6. The parties agree to enter into a confidential relationship with respect to the disclosure of certain proprietary and confidential information ("Confidential Information").
7. Applicant is required to pay the course fee in full in the case of any forms of disclosure (with reference to clause number 6).
8. Decision of the Management for the Financial Assistance Assessment shall be final and binding. No further correspondence will be entertained in this regard.

## **Referral Incentive Scheme**

### **Terms & Conditions**

1. Referral incentive(s) will be rewarded to the referrer upon successful registration and enrolment of the prospective student onto DIMENSIONS' Cambridge Primary Programme(s) / High School Programme(s), and only after the prospective student completes the payment for at least half of the course fees.
2. This scheme is available to all new students and our existing students. This scheme is not available to any organisations or personnel who are contracted to work as Recruitment Agents by DIMENSIONS.
3. The procedure of providing the referral incentive varies according to the status of the referrer (new or existing students) and the payment method of the course fees (full payment or by instalments).
4. If school fees are to be paid in full, referral incentive(s) will be rendered through an immediate deduction of \$500 from the remaining course fees (excluding application fee).

5. If school fees are to be paid in instalments, referral incentive(s) will be rendered through a deduction of \$500 from the last instalment.

### **Sibling Discount Scheme**
